THE COURT ORDERS THAT:

1. Leave be granted to the Plaintiffs to inspect and copy in the Registry, the documents produced in accordance with the Orders for Production filed 27 March 2026 and addressed to:
 - a. Hamilton Locke Pty Ltd (**Packet S48**), subject to note A below;
 - b. Alceon Group Pty Ltd (**Packet S50**); and
 - c. BDO Audit Pty Ltd (**Packet S51**).
2. Leave be also granted to the solicitors for the Plaintiffs to uplift these documents, physically for the purposes of inspection and copying, on the following conditions if original documents rather than copies have been produced:
 - a. The solicitor provides to the Registry a letter of consent from the person to whom the Order for Production is addressed;
 - b. Documents to not leave the custody of the solicitor, or counsel instructed by the solicitor;



- c. Documents to be returned to the Registry in the same condition, order and packaging as when uplifted; and
 - d. Documents to be returned promptly and, in any event, when an officer of the Registry so requests.
3. On completion of this matter, the Registrar may return to the addressees of the Orders for Production any document without giving the issuing party any further notice.
4. The Orders for Production dated 12 and 27 March 2026 addressed to the following be adjourned to the Examination for Production list before a Registrar at **11:00 am on Wednesday, 19 August 2026 at Law Courts Building, Queens Square, Sydney**, to be heard remotely by WebEx:
- a. David Anthony Clarke;
 - b. Hamilton Locke Pty Ltd;
 - c. Luke Anthony Softa;
 - d. Nicholas Edwards; and
 - e. Richard Facioni.

THE COURT NOTES THAT:

- A. The plaintiffs will not inspect Packets S48 and will treat this packet as Further Potentially Privileged Documents in accordance with orders made by Justice Markovic in matter NSD757/2026 on 4 June 2026:
- a. within two days of obtaining access to the Additional Packets, the plaintiffs are to send an instruction to LawInOrder to create a sub-set of documents, by searching or otherwise applying filters to the documents contained in the Additional Packets for documents created between 1 January 2020 and 1 July 2025 (inclusive) and which:
 - i. are sent to, received from or are otherwise cc'd to Nicholas Edwards;
 - or
 - ii. contain any one or more of the words "safe harbour" or "588GA" or "588",(the **Further Potentially Privileged Documents**),
 - b. within two days of obtaining access to the Additional Packets, the plaintiffs are to instruct LawInOrder to:



- i. place the Further Potentially Privileged Documents into a separate electronic location (for instance, “cold storage”), not to be accessible by the plaintiffs until further order;
- ii. provide a list of Further Potentially Privileged Documents to the plaintiffs and to the Directors as soon as reasonably practicable; and
- iii. make available, as soon as reasonably practicable, the Further Potentially Privileged Documents to the Directors by:
 - A. delivering up a separate electronic bundle (including the image files, load files, and any metadata regarding the same) of the Further Potentially Privileged Documents through an electronic file sharing platform or by hard drive; or
 - B. if requested by a Relevant Director, providing, at the relevant Director’s cost, access to a separate Relativity workspace, not accessible to the plaintiffs.

Subsection 35A (5) of the *Federal Court of Australia Act 1976* (the *Act*) provides that a party to proceedings in which a Registrar has exercised any of the powers of the Court under subsection 35A (1) of the Act may, within the time prescribed by the Rules of Court, or within any further time allowed in accordance with the Rules of Court, apply to the Court to review that exercise of power.
