Priority Dividend

A first and final priority dividend at the rate of 77.36 cents in the dollar was paid to priority creditors for outstanding wages and superannuation entitlements on 19 September 2025.

If you have supplied your EFT details, payment has been made directly to your nominated account.

Notwithstanding our multiple requests a number of employees have failed to provide EFT details to enable us to pay them a dividend on their outstanding wages. The employees who have not provided EFT details, and accordingly have not received their dividend payment are listed below.

We make a final request for these employees to provide EFT bank details by **10 October 2025**, to allow us to pay a priority dividend to these employees.

In the event these employees fail to provide EFT details (or alternate method of paying the dividend to employees), the balance of funds held to pay the dividend will be remitted to the Australian Securities and Investment Commissions (ASIC) unclaimed monies, where you may then claim it directly from ASIC.

ASIC website (<https://www.asic.gov.au/for-consumers/unclaimed-money/#why>) outlines unclaimed money received by ASIC is transferred to the Commonwealth of Australia Consolidated Revenue Fund. ASIC maintains and publishes a database of unclaimed money records which helps people find and claim their lost money. The rightful owner can claim their money at any time – there is no time limit. Superannuation Guarantee Charge (SGC) – Outstanding Information

To lodge the SGC statement and pay any priority dividend for superannuation liabilities to the ATO, the ATO requires a Tax File Number (TFN) and current postal address from the employees listed below.

Without this information, we cannot complete the SGC lodgement or remit the priority dividend.


